Statutory individual income tax rates are the tax rates that apply by law to various amounts of taxable income. Statutory rates lay the foundation for marginal and average effective tax rates which most economists believe have a greater impact on the economic behavior of companies and individuals than statutory rates. Marginal effective rates reflect the net effect of special tax provisions on statutory rates. They are to be distinguished from average effective rates which measure someone's tax burden. Current statutory and effective individual tax rates are the result of the Tax Reform Act of 1986 (TRA86) P.L. 99-514 and several tax laws that have been enacted since 1986. Of particular importance are the Omnibus Budget Reconciliation Act of 1990 (OBRA90) P.L. 101-508 the Omnibus Budget Reconciliation Act of 1993 (OBRA93) P.L. 103-66 the Economic Growth and Tax Relief Reconciliation Act of 2001 (EGTRRA) P.L. 107-216 the Tax Relief, Unemployment Insurance Reauthorization and Job Creation Act of 2010 (TRUC) P.L. 111-312 and the American Taxpayer Relief Act of 2012 (ATRA) P.L. 112-240. TRA86 made major changes in the income tax rate structure. EGTRRA
